Distribution of SCT Tokens

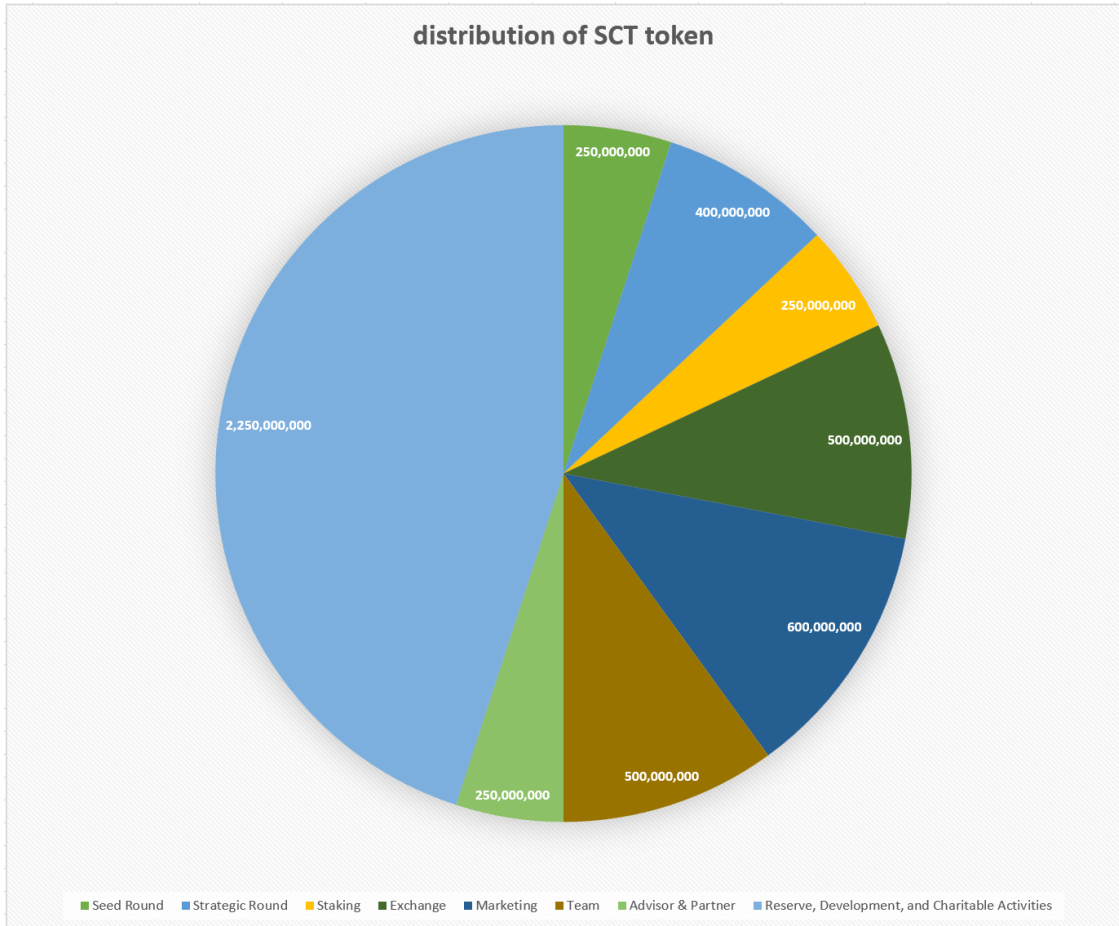
The above table shows the breakdown of SCT token supply distribution among the SCT ecosystem wallets.

Key Features of SuperCells Token Issuance and Management

Token Burn Function: Adjust the token supply in the market through burning to stabilize the token's value.

Flexible Minting Schedule: SuperCells can flexibly adjust the minting schedule of tokens according to market demand and the development status of the ecosystem.

Category	Token Amount	Percentage	Vesting Methods
Seed Round	250,000,000	5%	Starting from the participation date, 12.5% of the allocated tokens will be released every 3 months over a period of 24 months.
Strategic Round	400,000,000	8%	Starting from the participation date, 12.5% of the allocation will be released every 3 months over a period of 24 months.
Staking	250,000,000	5%	After the app launch, it will be allocated as a staking incentive. The percentage will depend on the staking period

3. Wallet

1. Objectives

Supercells is a currency and payment platform that can be used for medical and cosmetic services as well as stem cell treatments. By using the SCT wallet, medical and cosmetic procedures, which were previously expensive and complex, become more affordable and accessible. 2. SC: Community Expansion

3. SC Wallet Features (Upcoming)

1. **Staking:** By staking SCT tokens, you can earn additional rewards. Staking involves depositing your owned tokens into a specific platform to contribute to the security and operation of the network. Rewards are typically allocated to network operators and users participating in staking.

2. **Token Swap:** You can easily exchange SCT tokens for other tokens. Token swap refers to exchanging different cryptocurrencies, typically done through decentralized exchanges or swap platforms. This allows users to easily acquire or exchange their preferred tokens. This feature is intended to be integrated with platforms operated by licensed exchange operators.

3. **Expansion of E-commerce Functionality:** You can purchase beauty products or exchange them for discount vouchers. E-commerce functionality, abbreviated as EC, refers to the capability to purchase goods or services through online stores or platforms.

4. **Reservation Feature:** In the initial phase, we will enable reservations at 20 partner clinics. This functionality will allow users to make reservations at partner clinics using SCT tokens in the future. This signifies an expansion of the utility of SCT tokens.

4. Initial Action and Future Outlook

In the initial phase, SC tokens will primarily be used as a currency that can be exchanged for points or discount coupons, with points being viewable within the wallet. Users can swap at a rate of 10 points to 1 SCT. Through the SC Wallet, users can exchange SC tokens for

points or discount coupons from various partners, enjoying more benefits and convenience. Over time, we will strive to increase the value of SC tokens, turning them into tokens with real payment value.

To enhance the value of SC tokens, we plan the following methods:

1. **Expansion of Partner Network:**We will partner with more companies and service providers to broaden the use cases for SC tokens.
2. **Improvement of User Experience:**We will optimize the wallet's usage process and interface to make transactions and exchanges easier for users.
3. **Promotion and Advertising:**We will increase the awareness and recognition of SC tokens through various marketing strategies and events.
4. **Technical Upgrades:**We will continuously improve and upgrade blockchain technology to ensure transaction security and efficiency.

Through these efforts, we believe SC tokens will gradually gain real payment value, offering users even greater convenience and benefits.

July 2024 Onwards

- Creation of Review Platform and Wallet Development

Starting in July 2024, we will create a user review platform. This feature will allow users to share their actual experiences with medical and beauty services, as well as stem cell treatments, to help other users make informed decisions. By enhancing the reliability and transparency of reviews, we aim to increase the platform's value.

September 2024 Onwards

- Release of SC Wallet Beta Version
- Application for SC Wallet on iOS and Google Android
- Release of Review Platform Tokyo Beta Version
- Application for Review Platform on iOS and Google Android

Beginning in September 2024, we will create a dedicated application. This application will make it easier for users to access the platform, manage and trade SCT tokens, and utilize services more conveniently.

October - December 2024

- Release of Official SC Wallet Version
- Release of Official Tokyo Version of the Medical and Beauty Clinic Review Platform

January 2025 Onwards

- Expansion of Review Platform to Osaka, Nagoya, and Fukuoka

June 2025 Onwards

- Nationwide Release of the Review Platform

August 2024

- Strengthening Sales Activities and Expanding Partnerships

From August 2024, we will intensify sales activities and expand new partnerships. This includes increasing partnerships with domestic and international medical and beauty clinics to improve the range and quality of services offered.

August 2024

- Fundraising

Starting in June 2024, we will begin fundraising activities. Fundraising is a crucial element to execute the above plans, ensuring the necessary funds to support development and marketing activities.
